Sub :- COVID -19 – Vijayawada Division – Ibrahimpatnam Mandal - Red Zones / Hot Zones - identification of +ve case in Ibrahimpatnam Village of Ibrahimpatnam Mandal - Declared as Red zone for taking Containment measures for the entire village up to 3Kms – Orders issued – Reg.

ORDER

In the reference 3rd read above the D.M & H.O. Krishna has reported that after analysing the lab report it was brought to notice that one person by name Sri. Nadakuditi Veera raju S/o Rama kotaiah resident of Ibrahimpatnam village and Mandal is a +ve case and he has to be admitted in Government General Hospital, Vijayawada.

On enquiry it reveals that he was getting lab results as +ve he was admitted by himself in Narayana College, Gudavalli Village Vijayawada Rural Mandal.

Keeping in view of the above incidents it is hereby ordered that in exercise of the powers conferred vide in G.O.Rt No.189, G.O.Rt No.202 of Medical & Family Welfare Department, dated 13.03.2020 and dated 18.03.2020 the area upto 3 Kms radius of Ibrahimpatnam village of Ibrahimpatnam Mandal was declared as containment area (Red Zone) and the vehicles and the public should not be allowed in that containment area. The officers concerned has to be taken up all precautionary measures to prevent the spreading of covid virus. The following are the villages under with in the radius of 3 Kms of Ibrahimpatnam.

Name of the Mandal	Villages
Ibrahimpatnam	Ibrahimpatnam, Tummalapalem.

Measures to be taken in Containment area:-

1. To make barricading and sealing of entire 3 Kms geographical area around the identified Corona Positive cases in Ibrahimpatnam Village.
2. Barricading with entry and exit up to 3 Kms radius may be arranged to prevent the passage of vehicles and public except for the purpose of medical and essential commodities.
3. School, cinema halls, commercial establishments, offices and banning of public gatherings should not be opened.
4. Complete barricading up to 3 Kms radius to prevent the public and vehicle movement.

Active Surveillance within the Containment Zone

1. Active Surveillance (door to door survey) of all the households within the containment zone must start immediately by a team lead by Medical Officer, Team must have group of ASHA, ANM.
2. Immediate isolation and testing of all the individuals who have symptoms.
3. All the surveillance workers must be provided with safety masks and gloves.

Passive Surveillance outside the containment zone up to 5 km

1. All the hospitals and institutions up to 3 kms shall be visited by medical officer to check if any cases were reported in last one week.
2. Random houses may be selected to enquire about presence of symptomatic patients.
3. General public to be motivated to come forward to get the tests done in case of presence of symptoms.

Contact Tracing:

1. Contact tracing of positive patient must be done immediately by a special team consisting of Tahsildar, MPDO and Station House Officer.
2. All such contacts must be compulsorily kept in home quarantine.
3. If such contacts cannot be kept in home quarantine, they must be shifted to institutional quarantine immediately.
4. Designating any Government building for containment unit for isolation of cases, providing PPE kits to all round level/front line staff.

Sanitation:

1. Intensive Cleaning of the entire containment area/Red Zone with Sodium Hypochlorite Solution under the leadership of **MPDO**. Team must have EO PRRD and Panchayat Secretary.
2. Safe management of all the biomedical wastes within the area.
3. All Sanitary workers to be provided with safety masks and hand gloves.

Supply of Essential Commodities and Medical Services:


1. Arrangements must be made for door delivery of Vegetables. General rations and Milk so that unnecessary public outflow is avoided. Medical shops shall be open for the common public.
2. Ambulance must be kept ready to shift patients in case of emergency.
3. Area Hospital must be ready to accept patients. Superintendent of Area Hospital will be responsible for immediate medical needs.

Wide publicity must be given regarding containment orders to the general public via print and electronic media. All government servants will be at disposal of Divisional Administration of the concerned area for discharging the duty of containment measures. All the leaves given to any concerned in the area stay cancelled until further notice.
