Sir we have planned the following things before opening of our Institution.

- 1) All working areas intended for teaching are sanitized with 1% Sodium hypochlorite solution on daily Basis.
- 2) All the places which were used as quarantine centers have been properly sanitized as per the guidelines issued by Ministry of Health and Family welfare.
- 3) All the training equipments are properly sanitized and kept 6 feet apart wherever feasible.
- 4) Proper care will be taken during teaching to maintain social distancing between teacher & student and between students.
- 5) Thermal guns and sanitizer stands will be kept at the main building entrance and also sanitizer stands will be kept in front of lecture halls & labs.
- 6) It will be monitored that students and staff are using face mask and maintaining physical distancing of 6 feet between persons all the time.
- 7) Staff who are at risk will be instructed not to come in direct contact with the students.
- 8) Mask and sanitizers are made available to faculty and employees.

9) Thermal guns, pulse oximeters, sanitizers, disposable paper towels and soaps with hand washing facilities and dust bins are available.

10) Our hospital was COVID centre and housekeeping employees are well trained for management of waste and its disposal.

11) Posters on preventive measures about COVID -19 are displayed and a security guard is looking after crowd in the parking lot and entry of unauthorized guest in the premises.

12) Students will not be allowed to share pen, pencil or note book and those who are coming to college from hostel are instructed not to come in groups and for those coming in bus, from long distances a 50 seater bus is provided for 20 students.

13) Cafeteria for staff and students is closed since last 8months and it will be remained closed.

14)The batches are already divided and each batch will be entertained for class room teaching for 10 days only and rest of the period they will be attending online classes and assignment through email and record will be maintained. Once the batches are over the cycle will be repeated after first three 10 days duration of instructions is completed. The hostel accommodation will be given for 10 working days for each batch of the students.

15) We will record the lectures to make learning materials available to students not attending classes.

16) Each lecture class will be of 45 minutes duration with doors and windows kept opened and a break of 5 to 10 minutes between the classes will be provided.

17) Audios and Videos of lectures will be uploaded on website from time to time to facilitate learning at home.

18) Students congregation and mingling of students of one class with another will be totally prohibited.

19) Sports and extra curricular activities will be banned till the further instructions from MOH or WHO.

20) As far as possible a single room accommodation will be provided to students which will be periodically sanitize and hostels will be fumigated from time to time at regular intervals.

Hope the above strategies will fulfill the criteria for reopening of college.
