## ORDER:

Further in view of steady increase of Covid-19 Cases and there is need of adequate bed capacity in the district and Qualitative medical services to the general public. Hence it is decided to propose Dr.Pinnamaneni Siddhartha Institute of Medical Sciences, Gannavaram and NIMRA INSTITUTE OF MEDICAL SCIENCES AND RESEARCH CENTER as District COVID Hospitals.

Dr.Pinnamaneni Siddhartha Institute of Medical Sciences, Gannavaram and NIMRA INSTITUTE OF MEDICAL SCIENCES AND RESEARCH CENTER were previously notified as District COVID Hospital for Krishna District by the Government of Andhra Pradesh and the services were utilized in containing COVID in the pandemic period effectively. Hence, it is here by ordered that, Dr.Pinnamaneni Siddhartha Institute of Medical Sciences, Gannavaram and NIMRA INSTITUTE OF MEDICAL SCIENCES AND RESEARCH CENTER are notified District COVID Hospitals for Krishna District. The DM&HO, Krishna shall make necessary arrangements.
